2. TERMS AND CONDITIONS IN RESPECT OF ESSENTIALS QUALIFICATION(S) AND ESSENTIALS EXPERIENCE **(As mentioned under above Table-1)**

- 2.1 Only full time regular courses will be considered as specified under the minimum essential qualification(s) column in Table-1.**
- 2.2 All minimum essential qualification(s) must be from UGC recognized Indian University/ UGC recognized Indian Deemed University or AICTE approved courses from Autonomous Indian Institutions/ concerned statutory council (where ever applicable). Diploma in Engineering qualifications (if applicable) should be recognized by respective State Board of Technical Education.
- 2.3 Minimum percentage of marks in the essential qualification (s), as specified shall be considered as per institute / University rules / norms.
- 2.4 Whenever CGPA/OGPA or letter grade in a Degree is awarded, equivalent percentage of marks should be indicated in the application form as per norms adopted by University / Institutes. Candidates will be required to submit documentary proof / certificate to this effect from the Institute /University at the time of Interview, if called for the same.
- 2.5 Engineering Degree can be B.E./ B.Tch. / B.Sc. Engineering.
- 2.6 Candidates having 05 Years B.E / B. Tech + M.E / M. Tech integrated dual degree in engineering in relevant discipline shall also be considered.
- 2.7 Minimum Essential Experience in Large Organization should be as on 30th June,2019.

3.0 EMOLUMENTS

- 3.1 Selected candidates will be placed in the pre revised pay scale of Rs 11,000 – 14,500/-(M-3 Grade) (to be revised shortly) at the basic pay of Rs 11,000/-with one year probation in M-3 Grade and in the pre revised pay scale of Rs 7,500 – 9,500/-(M-1 Grade) (to be revised shortly) at the basic pay of Rs 7,500/-with one year probation in M-1 Grade.
- 3.2. **Pay and allowances in the pre revised pay scale & allowances:** Basic Pay as applicable in the grade, Special Pay (50% of basic pay), DA (IDA) at the applicable rates (257.5% at present as per AICPI) on basic pay and special pay. Total gross salary (Pre revised) is Rs.58,988/- in M-3 Grade and Total gross salary (Pre-revised) is Rs.40,219/- in M-1 Grade.
