Dear Customer,

You have been provided with a domestic PNG connection by Tripura Natural Gas Company Limited against registration made by you.

You might also be owning an LPG connection, provided by a government oil company, for you/your family at present. In this connection we shall like to draw your kind attention to an important provision of The Liquefied Petroleum Gas (Regulation of Supply and Distribution) Order, 2000 as amended vide notification dated September 10, 2009 which has mentioned supply of PNG to an LPG domestic consumer as prohibited activity as follows -

Prohibited Activity (For Piped Natural Gas Companies)

QUOTE

Continue to supply of Piped Natural Gas, to an existing consumer of domestic LPG of a Government Oil Company, who has not surrendered domestic LPG connection after sixty days from the date of obtaining the Piped Natural Gas connection, as prohibited activity.

UNQUOTE

To enable us comply with the provisions of Ministry of Petroleum & Natural Gas (MOP&NG), Government of India to enforce the provisions of The Liquefied Petroleum Gas (Regulation of Supply and Distribution) Order, 2000 as amended vide notification dated September 10, 2009 you are requested to furnish an undertaking to surrender / place under "safe custody" LPG connection in your name or in the name of other adult member of your household living with you at the dwelling unit at which you have been provided a PNG connection by IGL.

In case you have already surrendered / placed under "safe custody" LPG connection that you had, the details of same can also be furnished in the same undertaking. Kindly furnish the required undertaking in the enclosed format to the following address –

Kindly subscribe "UNDERTAKING" on the top right end of the envelope enclosing the said undertaking. In case of non receipt of the undertaking we shall be constrained to discontinue the supply of Piped Natural Gas.
